

## **Consent to the processing of personal data of the User of the website <https://polati.ru/>**

I, the personal data subject, hereinafter referred to as the “User,” by submitting my data on the Internet at: <https://polati.ru/> (hereinafter referred to as the “Website”), pursuant to the requirements of Federal Law No. 152-FZ of July 27, 2006 “On Personal Data,” acting freely, of my own will and in my own interest, **hereby give my consent** to the Website owner, OOO POLATI

(registered address: 141006, Moscow Oblast, Mytishchi, 29A Olimpiyskiy Prospekt, office 402, OGRN (Primary State Registration Number) 1145029009982, INN (Tax Identification Number) 5029188770) (hereinafter referred to as the “Operator”), for the processing of my personal data on the following terms:

### **1. Purposes of personal data processing.**

- 1.1. User identification when using the Website.
- 1.2. Providing access to the Website, its content, and functionality.
- 1.3. Processing of inquiries and applications.
- 1.4. Establishing feedback.
- 1.5. Verification of the completeness of the data provided by the User.
- 1.6. Providing effective customer and technical support in case of issues with the Website.
- 1.7. Collection of statistics by the Operator.

### **2. List of personal data subject to processing**

2.1. The Operator processes personal data of the User only when such data is submitted by the User independently via dedicated forms on the Website or sent by email to: [agreements@polati.ru](mailto:agreements@polati.ru). By filling out the relevant forms and/or submitting personal data, the User agrees to the Operator’s Personal Data Processing Policy available at: [https://polati.ru/en/footer/personal\\_data\\_policy\\_doc](https://polati.ru/en/footer/personal_data_policy_doc).

2.2. Data submitted by the User via forms on the Website:

- full name;
- e-mail;
- position/role in the project;
- contact information in messengers;
- telephone number;
- other data specified by the User.

2.2. Data automatically transmitted during viewing or when visiting the Website:

- IP address;
- cookie information;
- browser information;
- access time;
- referrer (address of the previous page).

### **3. List of actions with personal data.**

3.1. Collection, recording, systematization, accumulation, storage, clarification (updating, modification), retrieval, use, transfer, anonymization, blocking, deletion, destruction of the User’s personal data.

### **4. Method of personal data processing.**

4.1. Automated processing.

## **5. Term of this consent.**

5.1. Until the purposes of processing the User's personal data are achieved, or until this consent is withdrawn by the personal data subject, or until other lawful grounds for terminating the processing of the User's personal data arise.

## **6. Procedure for withdrawal of consent**

6.1. The User may withdraw this consent at any time by sending a written request in free form via registered mail with delivery confirmation to the Operator's address or by email to: [agreements@polati.ru](mailto:agreements@polati.ru). The request must include the User's full name, phone number, and the note "Withdrawal of Consent to the Processing of Personal Data."

Upon achieving the objectives of personal data processing, as well as in the event of the User's revoking consent to the processing of personal data, personal data are subject to destruction in accordance with the requirements of Federal Law No. 152-FZ of 27.07.2006 "On Personal Data" and the organizational and administrative documentation of the Operator.

## **7. The Users hereby agrees and confirms that:**
